Chapter 1. General Provisions

Article 1 (Purpose) The purpose of these Regulations is to provide for details of matters pertaining to the academic affairs of Korea University (hereinafter referred to as the "University") in accordance with Article 4(3) of the *Constitution of Korea University* (hereinafter referred to as the "Constitution").

Article 2 (Detailed Enforcement Regulations, Bylaws, and Guidelines) (1) Matters in these Regulations that necessitate more detailed regulation may be stipulated in detailed enforcement regulations.

- (2) Details of matters that are inappropriate for regulation through detailed enforcement regulations may be stipulated in bylaws or internal guidelines (hereinafter referred to as "guidelines") of colleges (divisions/schools), departments, or offices in charge of such matters.
- (3) Bylaws of colleges (divisions/schools) or departments in paragraph 2 may be valid only when all of the requirements set forth in the following subparagraphs are met:
- 1. Bylaws must have been adopted by a resolution of the faculty council of the college (division/school) or department concerned;
- 2. Bylaws must have been approved by the President;
- 3. The provisions of bylaws must not conflict with the purpose of these Regulations;
- 4. The provisions of bylaws must not fall short of the standards set forth in these Regulations.
- (4) The resolution of the faculty council in subparagraph 1 of paragraph 3 shall require the attendance of a majority of the incumbent faculty members and an affirmative vote of a majority of those present.

Article 3 (Amendment) (1) The procedure and method for amending these Regulations shall be in accordance with the *Regulations on the Management, Etc. of University Regulations*.

- (2) Amendment to the matters set forth in the following subparagraphs shall be approved by the Korea University Foundation:
- 1. Establishment or closedown of education centers specified in subparagraph 1 of Article 8(1) of the Constitution;
- 2. Change in an admission quota exceeding 30 students.

Chapter 2. Administration of Registration Status

Section 1. Registration

Subsection 1. Admission

- Article 4 (Eligibility for Admission and Procedure) (1) (Prospective) High school graduates and those acknowledged by relevant law as having equivalent qualifications shall be eligible for admission to a bachelor's degree program of the University.
 - (2) Eligibility for admission to a combined bachelor-master degree program shall be identical to that required for admission to a bachelor's degree program as set forth in paragraph 1. *Newly inserted on Apr. 15, 2022*
 - (3) Admission shall be undertaken upon permission of the President.
 - (4) Those who are admitted (including transfer students) must pay tuition within the specified period and comply with all other procedures set forth by the University.
 - (5) Admission may be revoked in the event the procedures set forth in paragraph 4 are not complied with.
- Article 5 (Types of Admission) (1) Types of admission shall be as set forth in the following subparagraphs:
 - 1. Admission within the quota;
 - 2. Admission beyond the quota.
 - (2) Admission beyond the quota shall be undertaken in accordance with the standards set forth in relevant law and University regulations.
- Article 6 (Admission Quota) The organization of departments for each college (division/school) and the admission quota for each admission unit shall be determined for each academic year and stipulated in detailed enforcement regulations.
- Article 7 (Admission Screening) (1) Selection of students shall be undertaken based on an entrance examination or screening separately provided.
 - (2) The procedure and method of admission shall be announced in the admission guidelines.
 - (3) A committee may be established and operated to ensure rationality and equity in the admission process.
- Article 8 (Revocation of Admission) (1) Admission to the University must be revoked in the event any of the circumstances set forth in the following subparagraphs is confirmed with respect to newly admitted students, currently registered students, and students who have graduated from the University. *Amended on Sep. 1, 2022*
 - 1. In the event there had been a serious defect in the documents submitted for admission screening; *Amended on Sep. 1, 2022*
 - 2. In the event fraudulent documents, such as documents with fabricated information or falsified or forged documents, had been submitted for admission screening; *Amended on Sep. 1, 2022*
 - 3. In the event proxy test taking occurred in admission screening; Newly inserted on Sep. 1, 2022
 - 4. In the event the student otherwise engaged in illegitimate or deceptive acts that adversely affected equitable implementation and management of admission screening, such as looking at the answer sheet of other applicants or showing his/her answer sheet to other applicants during entrance examination. *Newly inserted on Sep. 1, 2022*
 - (2) Details of matters pertaining to revocation of admission shall be separated provided for in the Regulations for Admission to and Management and Operation of the University. Newly inserted on Sep. 1, 2022

Subsection 2. Transfer

Article 9 (Types and Eligibility for Application) (1) Transfers shall be classified as set forth in the following subparagraphs:

- 1. General transfer: transfer of those who have completed a certain part of their bachelor's degree program at a university or those acknowledged by relevant law as having equivalent qualifications to the University to continue with their degree program;
- 2. Second bachelor's degree transfer: transfer of those who have acquired a bachelor's degree to the University;
- 3. Special transfer: transfer of those whose school or department ceased to exist under relevant law to an identical or similar admission unit of the University.
- (2) Eligibility for applying to general transfer shall be as set forth in the following subparagraphs:
- 1. Transfer to the second year of a bachelor's degree program: those who have completed at least the first year of a four-year regular university, have graduated or is expected to graduate from a junior

college, or have equivalent or higher qualifications;

- 2. Transfer to the third year of a bachelor's degree program: those who have completed at least the second year of a four-year regular university, have graduated or are expected to graduate from a junior college, or have equivalent or higher qualifications;
- 3. Those acknowledged by relevant law, such as the Higher Education Act and the Enforcement Decree of the Higher Education Act, and University regulations as having qualifications equivalent to those set forth in subparagraphs 1 and 2.
- (3) The school year for transfer students in subparagraphs 1 and 2 of paragraph 2 shall be determined based on Article 35.
- (4) Second bachelor's degree transfer students shall begin in their third year upon entrance to the University.
- (5) Eligibility for applying to special transfer shall be in accordance with the guidelines of the Ministry of Education on special transfers.
- Article 10 (Programs Subject to Application) Details of matters pertaining to the programs subject to application for transfer students shall be determined based on the guidelines for transfer students announced by the University for the academic year concerned.
- Article 11 (Admission Screening for Transfer Students) (1) Admission screening for transfer students may be composed of written examinations, performance tests, and oral interviews.
 - (2) Details of matters pertaining to the admission screening for transfer students shall be determined based on the guidelines for transfer students announced by the University for the academic year concerned.
- Article 12 (Credit Acknowledgment for General and Special Transfer Students) (1) Credit acknowledgment for general and special transfer students requires approval by the President following proposal by the department chair of their affiliated department.
 - (2) The maximum number of credits acknowledged under paragraph 1 shall not exceed 17 credits per semester (18 credits per semester for the colleges (divisions/schools) and departments specified in Article 57(2)).
 - (3) Courses for which credits have been acknowledged shall not be registered for again.
 - (4) With respect to general and special transfer students to the College of Education, credits acquired from taking major courses offered at their previous school shall be acknowledge only when their majors at the previous school and the University are identical.
 - (5) Credits acquired by general and special transfer students from their previous school may be acknowledged as major course credits acquired from the University, provided that the number of credits acknowledged does not exceed one-half of the required minimum for their first, second, and dual major.
- Article 13 (Credit Non-Acknowledgment for Second Bachelor's Degree Transfer Students) Credits acquired by second bachelor's degree transfer students from their previous school shall not be acknowledged.
- Article 14 (Credit Acquisition for General and Special Transfer Students) (1) General and special transfer students must acquire credits by completing the curriculum required by the University in addition to the credits acknowledged in accordance with Article 12.
 - (2) In order to pursue a first, second, or dual major, general and special transfer students must complete at least one-half of the minimum required credits for each major at the University.
- Article 15 (Credit Acquisition for Second Bachelor's Degree Transfer Students) (1) Second bachelor's degree transfer students must complete the courses offered under the curriculum of their affiliated department.
 - (2) The department chair of the department concerned may require second bachelor's degree transfer students to complete additional courses other than those specified in paragraph 1. *Amended on Sep. 1*, 2024
 - (3) The number of credits required for second bachelor's degree transfer students to graduate shall be as set forth in the following subparagraphs; students pursuing a second or dual major may acquire additional credits based on their selected major. *Amended on Sep. 1, 2024*
 - 1. Departments requiring acquisition of a minimum 130 credits for graduation: minimum 58 credits to a maximum 65 credits shall be required (number of credits required for graduation of second bachelor's degree transfer students to the College of Nursing shall be separately determined);
 - 2. Departments requiring acquisition of a minimum 135 credits for graduation: minimum 60 credits to a maximum 70 credits shall be required.

at their previous school may be acknowledged as set forth in the following subparagraphs:

- 1. Transfer to the second year of a bachelor's degree program: maximum two semesters may be acknowledged for students transferring in the spring semester and a maximum three semesters may be acknowledged for students transferring in the fall semester;
- 2. Transfer to the third year of a bachelor's degree program: maximum four semesters may be acknowledged.

Subsection 3. Readmission

- Article 17 (Eligibility) (1) Readmission shall be available for those who have withdrawn from the University after attending the University for at least one semester. However, readmission shall not be permitted to students who have withdrawn from the University due to the expiration of the time limit for degree completion specified in Article 38. *Amended on Sep. 1, 2024*
 - (2) Readmission shall be possible after at least two semesters have elapsed since the student's withdrawal from the University. However, this requirement shall not apply to withdrawals under subparagraphs 1 and 2 of Article 20 of the Constitution.
 - (3) Readmission shall be permissible in the event of vacancy with respect to the student quota of the department concerned.
- Article 18 (Application and Permission) (1) Those intending to be readmitted to the University must submit an application for readmission form and other necessary documents to the dean of the college (division/school) concerned within the specified period.
 - (2) The dean of the college (division/school) concerned shall examine the eligibility of applicants for readmission and propose to the President readmission of successful applicants. The President may grant permission for the readmission of students following deliberation by the Student Registration Management.
 - (3) Readmission shall be granted upon comprehensively consideration of particular circumstances including reasons of withdrawal (e.g., expulsion).
 - (4) Readmission may be granted only once.
- Article 19 (School Year and Credit Acknowledgment) (1) Students readmitted to the University shall be readmitted to the school year identical to or lower than the one they were in at the time of withdrawal.
 - (2) With respect to readmitted students, credits acquired before readmission may be acknowledged.
- Article 20 (Registration, Etc.) Those readmitted to the University must complete necessary procedures including tuition payment (including readmission fee) and course registration within the specified period.

Section 2. Modification of Registration Status and Removal from the Student Register

Subsection 1. Department Transfer

- Article 21 (Eligibility) Students falling within any of the categories set forth in the following subparagraphs may transfer to another department:
 - 1. Students affiliated with colleges (divisions/schools) or departments where educational organization innovation has been conducted in accordance with the *Regulations on the Special Committee on Educational Organization Innovation*;
 - 2. Students who have been granted permission to change their affiliation to another college (division/school) or department within the same campus;
 - 3. Students who have been granted permission to change their affiliation to another college (division/school) or department at another campus.
- Article 22 (Detailed Enforcement Regulations) Details of matters pertaining to department transfers shall be separated provided for in detailed enforcement regulations.

Subsection 2. Leave of Absence

- Article 23 (Application and Permission for and Period of Leave of Absence) (1) Students intending to take leave of absence must apply for leave of absence in accordance with prescribed procedures and obtain permission from the President.
 - (2) Students may take leave of absence on either a semestrial or annual basis.
 - (3) The period of leave of absence shall not exceed a total of three years (six semesters).
 - (4) The application period for leave of absence shall be as set forth in the following:

Leave of absence for the spring semester: from February 1 to February 25; Leave of absence for the fall semester: from August 1 to August 25.

- Article 24 (Types of Leave of Absence) (1) Types of leave of absence shall be as set forth in the following subparagraphs:
 - 1. General leave of absence: leave of absence subject to the period set forth in Article 23(3);
 - 2. Special leave of absence: leave of absence not subject to the period set forth in Article 23(3).
 - (2) Types of special leave of absence in subparagraph 2 of paragraph 1 shall be as set forth in the following subparagraphs:
 - 1. Leave of absence due to pregnancy, childbirth, or child rearing: leave of absence for pregnancy, childbirth, or rearing children age eight years or younger;
 - 2. Leave of absence due to military service: leave of absence for military service (limited to mandatory military service; a period up to one year from the date of discharge may be acknowledged as part of the period of absence due to military service);
 - 3. Leave of absence due to business start-up: leave of absence for business start-up (limited to cases where the applicant is the representative of the business start-up; details of matters pertaining to leave of absence due to business start-up shall be separately provided for in bylaws or guidelines);
 - 4. Leave of absence due to crisis or infectious disease: leave of absence approved by the President only for the semester concerned due to incidents such as the outbreak of war, national crisis or infectious disease. *Newly inserted on Jan. 1, 2022*
- Article 25 (Extension of Period of General Leave of Absence) The period of general leave of absence for reasons set forth in the following subparagraphs may be extended upon proposal by the dean of the affiliated college (division/school).
 - 1. Leave of absence due to illness: may be extended by a maximum of one year (requires submission of a medical certificate requiring at least four-week treatment issued by the director of a hospital affiliated with the University or the director of a general hospital and a confirmation from the academic advisor or department chair);
 - 2. Leave for absence for professional training after passing a state-run examination: may be extended for the period designated for such professional training (requires submission of supporting documentation).
- Article 26 (Period of Special Leave of Absence) (1) The period of leave of absence due to pregnancy, childbirth, or child rearing shall not exceed two years.
 - (2) The period of leave of absence due to military service shall be limited to the period of leave of absence for mandatory military service. Students intending to voluntarily extend the period of military service must apply for general leave of absence for that extended period.
 - (3) The period of leave of absence due to business start-up shall not exceed two years (four semesters), provided that it may be extended by one year (two semesters) when certain conditions are met. Details of matters pertaining to this issue shall be separately provided for in the *Operational Guidelines on Leave of Absence for Business Start-up. Amended on Mar. 1, 2022; Sep. 1, 2024*
- Article 27 (Supporting Documentation for Application for Special Leave of Absence) Documents set forth in the following subparagraphs must be submitted as attachments when applying for special leave of absence:
 - 1. Leave of absence due to pregnancy, childbirth, or child rearing: hospital-issued medical certificate, family relations certificate, etc.;
 - 2. Leave of absence due to business start-up: application for leave of absence for business start-up, business license, business plan, letter of recommendation by business start-up related departments or academic advisor, and other supporting documents for business start-up activities.
- Article 28 (Leave of Absence during School Term) (1) Leave of absence during school term refers to leave of absence undertaken in the course of a semester after registration and the period set forth in Article 23(4). (2) In order to take leave of absence during the school term, students must submit an application for leave of absence to the administration office of their affiliated college (division/school) and obtain permission from the President within 89 days from the date of commencement of the semester. *Amended on Mar. 1, 2022; Sep. 1, 2024*
- Article 29 (Leave of Absence due to Military Service) (1) Students intending to enlist in the military must submit, before the date of enlistment (date of induction), an application for leave of absence for military service together with the notice of enlistment (military conscription notice).
 - (2) In the event the reason for taking leave of absence for military service ceases to exist due to termination or postponement of the student's enlistment in the military, the student must cancel the

application for leave of absence due to military service within seven days at the administration office of the affiliated college (division/school). *Amended on Mar. 1, 2022; Sep. 1, 2024*

- Article 30 (Restrictions on Leave of Absence) (1) Students falling within any of the categories set forth in the following subparagraphs shall not take leave of absence in the first semester after admission for reasons other than pregnancy, childbirth, child rearing, illness, military service, crisis or infectious disease; *Amended on Jan. 1*, 2022
 - 1. Newly admitted students;
 - 2. Transfer students;
 - 3 Readmitted students
 - (2) Students intending to apply for leave of absence due to illness in paragraph 1 must submit all of the documents set forth in the following subparagraphs:
 - 1. Medical certificate of inpatient treatment for at least four weeks (issued by the director of a hospital affiliated with the University or the director of a general hospital);
 - 2. Confirmation of hospitalization for at least four weeks.

Subsection 3. Return from Leave of Absence

- Article 31 (Application for Return from Leave of Absence) Students on leave of absence must apply for return from leave of absence within the period set forth in Article 23(4) upon expiration of the period of leave of absence or cessation of the reason for the leave of absence.
- Article 32 (Return from Military Leave) (1) Students on leave of absence for military service must apply for return from leave of absence within one year after their date of discharge and within the period set forth in Article 23(4) by submitting the documents set forth in the following subparagraphs:
 - 1. Application for return from leave of absence for military service;
 - 2. Copy of certificate of discharge or certificate of military service.
 - (2) Students on leave of absence for military service who fail to return and re-enroll without applying for a leave of absence, despite the lapse of one year from the date of their discharge, shall be withdrawn. *Amended on Sep. 1, 2024*
 - (3) Students expected to be discharged from the military service after the commencement of the semester and intending to return and re-enroll for that semester must meet all of the requirements set forth in the following subparagraphs:
 - 1. Students must be discharged before the commencement of the midterm exam of that semester;
 - 2. Students must submit the application for return from leave of absence and other supporting documentation within the period set forth in Article 23(4).

Subsection 4. Voluntary Withdrawal

- Article 33 (Application for Voluntary Withdrawal) Students intending to withdraw voluntarily must follow the prescribed procedures to complete a voluntary withdrawal form and submit it to the administration office of their affiliated college (division/school) after obtaining approval from their academic advisor. *Amended on Mar. 1, 2022; Sep. 1, 2024*
- Article 34 (Permission for Withdrawal) The President may grant permission for student withdrawal from the University.

Chapter 3. Administration of Academic Affairs

Section 1. School Year, Required Registration Period, and Time Limit for Degree Completion

- Article 35 (School Year) (1) The school year for enrolled students shall be as set forth in the following subparagraphs (credits specified in parentheses are for the colleges (divisions/schools) and departments specified in Article 57(2)).
 - 1. First year: students who have acquired a maximum of 33 (35) credits;
 - 2. Second year: students who have registered for at least three semesters and acquired a minimum of 34 (36) credits and a maximum of 67 (71) credits;
 - 3. Third year: students who have registered for at least five semesters and acquired a minimum of 68 (72) credits and a maximum of 101 (105) credits;
 - 4. Fourth year: students who have registered for at least seven semesters and acquired a minimum of 102 (106) credits.
 - (2) The school year of students affiliated with the College of Medicine and the Department of Pharmacy

of the College of Pharmacy shall be separately provided for in detailed enforcement regulations or bylaws. *Amended on Mar. 1, 2025*

- Article 36 (Calculation of Semesters) (1) The number of semesters attended by students shall be the number of registrations undertaken by them.
 - (2) Registered semesters in which credits are not acquired shall be counted toward the number of registrations undertaken by students.
- Article 37 (Required Registration Period) (1) The required registration period for bachelor's degree programs shall be four years, provided that the exceptions set forth in the following subparagraphs shall apply:
 - 1. Department of Architecture of the College of Engineering: five years;
 - 2. College of Medicine: six years;
 - 3. Second bachelor's degree transfer: two years (Department of Architecture: four years);
 - 4. General and special transfer to the second year of a bachelor's degree program: three years (Department of Architecture: four years);
 - 5. General and special transfer to the third year of a bachelor's degree program: two years (Department of Architecture: three years);
 - 6. Students pursuing a dual major in the Department of Architecture: additional three years may be granted;
 - 7. Department of Pharmacy of the College of Pharmacy: 6-year curriculum (for newly admitted and transfer students in the 6-year track); 4-year curriculum (for transfer students in the 4-year track).

Newly inserted on Mar. 1, 2022 and amended on Mar. 1, 2025

- (2) The required registration period may be reduced by a period not to exceed one year for students exhibiting high academic performance, except for students affiliated with the Department of Architecture of the College of Engineering, College of Medicine, Department of Cyber Defense, and Department of Pharmacy of the College of Pharmacy. *Amended on Sep. 1, 2024; Mar. 1, 2025*
- (3) The required registration period for integrated bachelor-master degree programs shall be separately provided for in the *Detailed Enforcement Regulations on the Operation of Integrated Bachelor-Master Degree Programs. Newly inserted on Apr. 15, 2022*
- Article 38 (Time Limit for Degree Completion) (1) The number of years assigned as the time limit for degree completion for bachelor's degree programs shall be twice the number of years assigned for their required registration period.
 - (2) With respect to students pursuing a dual major, the time limit for degree completion for their first major may be extended by two years. Students pursuing a dual major in the Department of Architecture may be granted additional six years for the time limit for degree completion.
 - (3) The time limit for degree completion for students affiliated with departments allowing students to repeat a school year may be extended by a maximum of one year, provided that special circumstances are considered.
 - (4) Periods of leave of absence and withdrawal shall not be counted toward time limit for degree completion.
 - (5) Students whose time limit for degree completion has expired shall be withdrawn from the University. However, such students' time limit for degree completion may be extended once by a maximum of one year upon request by the dean of their affiliated department (dean of their affiliated division/school in the case of independent division/school) and following deliberation by the relevant committee. This provision shall not apply in conjunction with paragraph 3. *Amended on Sep. 1, 2024*
 - (6) The period during which students maintain their registered student status pursuant to paragraph 1 or 2 of Article 62–2 shall be counted toward the time limit for degree completion. *Amended on Sep. 1*, 2024

Section 2. Tuition

- Article 39 (Tuition Payment) (1) Tuition shall be composed of course fee, admission fee, expenses approved by relevant law, and other payments.
 - (2) The amount and deadline for payment of tuition shall be announced before the commencement of the semester.
 - (3) Tuition shall be paid within 60 days before the commencement of the semester.
- Article 40 (Grounds for Tuition Refund) (1) Grounds for tuition refund shall be as set forth in the following subparagraphs:
 - 1. Tuition paid by those ineligible for admission (including readmission and transfer) and no longer able to continue their degree program by relevant law;

- 2. Tuition paid by those admitted to the University but have expressed their intent to decline their admission:
- 3. Tuition paid by students who have voluntarily withdrawn from the University;
- 4. Tuition paid by students who have been withdrawn from the University as a result of their exceeding the period of leave of absence after being registered;
- 5. Tuition paid by those who ultimately do not enter the University or fail to continue with their degree program as a result of illness, death, force majeure, or other unavoidable reasons;
- 6. Tuition paid by students who, after having registered, apply for leave of absence. Newly inserted on Dec. 1, 2014
- (2) Tuition shall not be refunded in the event student are no longer permitted to continue with their degree program as a result of disciplinary action.
- Article 41 (Standards for Tuition Refund) (1) Tuition paid shall be refunded in full in the event any of the circumstances specified in Article 40 occurs before the commencement of the semester (for those newly admitted, in the event any of the circumstances specified in Article 40 occurs before the date of admission).
 - (2) The admission fee shall not be refunded in the event any of the circumstances specified in Article 40 occurs after the commencement of the semester. Course fee shall be refunded in accordance with the standards set forth in the following subparagraphs:
 - 1. In the event any of the circumstances specified in Article 40 arises within 30 days from the date of commencement of the semester, 5/6 of the course fee shall be refunded.
 - 2. In the event any of the circumstances specified in Article 40 arises after the thirtieth day and within 60 days from the date of commencement of the semester, 2/3 of the course fee shall be refunded.
 - 3. In the event any of the circumstances specified in Article 40 arises after the sixtieth day and within 90 days from the date of commencement of the semester, 1/2 of the course fee shall be refunded.
 - (3) Tuition paid shall not be refunded in the event a ground for tuition refund arises after the 91st day from the date of commencement of the semester.
 - (4) Tuition paid by a student on leave of absence or withdrawn from the University shall be refunded in accordance with paragraph 2. However, tuition shall be refunded in full in the event the student applies for either a leave of absence or withdrawal within the application period for leave of absence set forth in Article 23(4) or before the deadline for registration. *Amended on Sep. 1, 2024*

Section 3. Registration for Courses

- Article 42 (Syllabus) Faculty members in charge of a course established at the University shall post the syllabus of the course online within the specified period so that students can refer to it when registering for courses.
- Article 43 (Period and Method of Course Registration) (1) Course registration shall be conducted within the period specified for each semester.
 - (2) Students must register for courses in accordance with the bylaws on the composition and completion of the curriculum of their affiliated department.
 - (3) The minimum and maximum number of credits for which students may register in a semester shall be 1 and 19, respectively. However, students affiliated with the following colleges (divisions/schools) or departments may register for a maximum of credits as set forth in the following subparagraphs:
 - 1. College of Medicine: 30 credits;
 - 2. College of Education and Department of Communications Engineering: 20 credits; *Amended on Mar.* 1, 2022; May 1, 2023; Sep. 1, 2024
 - 3. Department of Cyber Defense: 22 credits for students admitted up to the 2024 academic year and 20 credits for students admitted starting from the 2025 academic year; *Amended on Mar. 1, 2025*
 - 4. Department of Pharmacy of the College of Pharmacy: 21 credits for newly admitted students (six-year program) and 22 credits for transfer students (four-year program); *Newly inserted on Mar. 1, 2022 and amended on Mar. 1,2025*
 - (4) Students must take courses offered at their affiliated campus. However, students may acquire a total of 21 credits from major courses established at the other campus that are not offered at their affiliated campus, provided that such courses are registered for as general elective courses. *Amended on Sep. 1*, 2024
 - (5) Students shall not register for courses offered during the same class time period.
 - (6) Students may advance a maximum of three credits from the fall semester to the spring semester or carry over a maximum of three unused credits from the spring semester to the fall semester, provided that they comply with the maximum number of credits for which students may register in a semester as specified in paragraph 3. Newly inserted on Sep. 1, 2024

- (7) Notwithstanding paragraph 3, the minimum number of credits for which students may register in a semester may be set differently through consultation between the college (division/school) and the Office of Academic Affairs; details of matters pertaining to this issue shall be separately provided for in bylaws or guidelines of the college (division/school) concerned. *Newly inserted on Sep. 1, 2024*
- Article 44 (Extra Credit Registration) (1) Students falling within any of the categories set forth in the following subparagraphs may register for credits in excess of the scope set forth in Article 43(3) by a maximum of three credits (credits specified in parentheses are for the colleges (divisions/schools) and departments specified in Article 57(2)). *Amended on May 1, 2023*
 - 1. Students who have acquired an overall GPA of at least 3.75 without receiving a grade of F;
 - 2. Students who have acquired an overall GPA of at least 3.75 and at least 17 (18) credits in the immediately preceding semester (limited to regular semesters) without receiving a grade of F;
 - 3. Students in a combined bachelor-master degree program;
 - 4. Students in an integrated bachelor-master degree program. Newly inserted on Apr. 15, 2022
 - (2) Paragraph 1 shall not apply to students affiliated with the College of Medicine and the Department of Pharmacy of the College of Pharmacy. *Amended on Mar. 1, 2025*
 - (3) Students in the Reserve Officers' Training Corps (ROTC) may register for credits in excess of the scope set forth in Article 43(3) for the semesters in which such students register for military science courses, provided that such additional credits do not exceed the number of credits assigned for military science courses. *Amended on May 1*, 2023
 - (4) In the event students falling within any of the categories set forth in the subparagraphs of paragraph 1 and thus eligible to register for extra credits also fall under the status specified in paragraph 3, said students may register for an additional three credits in excess of the scope set forth in paragraph 3.
- Article 45 (Course Add/Drop) (1) Courses shall not be added or dropped after the specified course add/drop period.
 - (2) Students who need to add or drop courses after the course add/drop period on account of course cancellation shall do so during a separately designated period.
- Article 46 (Non-Registration of Courses and Non-Acquisition of Credits) Students who, without justifiable reasons, fail to register for courses or acquire credits after paying tuition shall nonetheless be deemed as having registered for the semester concerned.

Section 4. Credit Acquisition and Credit Acknowledgment

- Article 47 (Credits and Course Hours) (1) One credit shall be equal to 15 course hours per semester.
 - (2) With respect to courses separately designated by the President, such as those involving experiments, practica, and practical works, one credit shall in principle be equal to 30 course hours per semester; however, the Curriculum Steering Committee may establish different standards upon consideration of the particular nature of these courses. *Amended on Sep. 1, 2024*
- Article 47–2 (Class Cancellation and Make-up) Details of matters pertaining to class cancellation and make-up during school term shall be separately provided for in detailed enforcement regulations.
- Article 48 (Credit Acquisition per Semester) (1) The maximum number of credits that may be acquired by students per semester shall be as set forth in Articles 43(3), 43(6), and 44. *Amended on May 1, 2023; Sep. 1, 2024*
 - (2) Scholarships may require acquiring a certain number of credits. Matters pertaining to this issue shall be separately provided for in the *Scholarship Awarding Regulations*.
- Article 49 (Credit Acquisition from Summer or Winter Courses) (1) The maximum number of credits that may be acquired from summer or winter courses shall be six credits.
 - (2) Registration and attendance of summer or winter courses shall not be counted toward the number of registrations in Article 36(1) and the required registration period in Article 37.
 - (3) Credits acquired from summer or winter courses shall be indicated as summer or winter course credits on the academic transcript and counted toward the total number of credits acquired and the overall GPA.
- Article 50 (Course Registration and Credit Acquisition for Students on Leave of Absence) (1) Students on leave of absence may also take summer or winter courses. However, students on leave of absence who have met the requirements for graduation by acquiring credits from summer or winter courses may graduate only after completing at least one semester after returning from their leave of absence.

- (2) Students on leave of absence for military service in accordance with the Military Service Act may acquire a maximum of six credits per semester and 12 credits per year from courses designated by the University in accordance with prescribed procedures; a grade of P/F shall be granted for the courses so taken, and such courses shall be indicated as "courses taken during military service" on the academic transcript.
- Article 51 (Withdrawal of Acquired Credits) (1) Students shall not withdraw acquired credits. However, students may withdraw a maximum of six credits in the event course retake is not possible on account of course abolition; courses for which credits have been so withdrawn shall be indicated with "W" (Withdraw) on the academic transcript, and such withdrawn credits shall not be counted toward the GPA.
 - (2) In order to withdraw acquired credits, students must have registered for at least seven semesters and acquired a minimum of 102 credits (106 credits for the colleges (divisions/schools) and departments specified in Article 57(2)) and submit an application for credit withdrawal form within the specified period.
 - (3) The application for credit withdrawal from may be submitted only once, and such application shall not be withdrawn or modified.
 - (4) Credits for courses that have not been completed shall not be withdrawn.
 - (5) Courses for which credits have been withdrawn shall not be registered for again.
- Article 52 (Taking Graduate School Courses: Eligibility and Scope) (1) Graduate school courses that bachelor's degree program students may take shall be designated by the department chair of the graduate school concerned. However, professional graduate school courses that bachelor's degree program students may take shall be separately determined by the dean of the professional graduate school concerned.
 - (2) The course classification of graduate school courses completed by bachelor's degree program students shall be determined by their affiliated college (division/school) and department.
 - (3) To be eligible to take graduate school courses, students must be fourth-year bachelor's degree program students who have acquired an overall GPA of at least 3.50 from courses they have completed up to the immediately preceding semester. However, qualifications of students eligible to take professional graduate school courses shall be separately determined by the dean of the professional graduate school concerned.
 - (4) Notwithstanding paragraph 3, combined bachelor-master degree program students may take graduate school courses before entering a graduate program.
- Article 53 (Taking Graduate School Courses: Scope of Credit Acknowledgment) (1) Students may acquire a maximum of six credits from graduate school or professional graduate school courses designated by the graduate school or professional graduate school of the University concerned, and credits so acquired may be acknowledged and counted toward credits required for graduation. However, combined bachelor-master degree program students may, in accordance with University regulations, acquire more than six credits from graduate school courses before entering a graduate program.
 - (2) Credits acquired from graduate school courses during enrollment in a bachelor's degree program that exceed the number of credits required for graduation from a bachelor's degree program may be counted toward credits required for graduation from a graduate program.
- Article 54 (Credit Acknowledgment for Courses Taken from Other Universities: General Provisions) (1) Students of the University may study at other domestic or foreign universities.
 - (2) The study in paragraph 1 requires permission of the President following a proposal by the department chair of the students' affiliated college (division/school).
 - (3) The number of credits acquired from courses offered at other universities may be acknowledged as those acquired from the University, provided that the number of credits acknowledged does not exceed one-half of the required minimum for graduation. With respect to transfer students, the number of credits acquired from courses offered at other universities that may be acknowledged shall not exceed one-half of the credits required by the University (in addition to the credits acquired during their enrollment at their previous school and acknowledged as those acquired from the University).
 - (4) Credit acknowledgement in cases where a dual degree program is administered with another university as specified in Article 43 of the Constitution of Korea University shall be separately provided for in the Detailed Enforcement Regulations on the Operation of Dual Degree Programs. Newly inserted on Sep. 1, 2024
- Article 54–2 (Credit Acknowledgment for Off-Campus Courses) (1) Students may acquire the credits specified in Articles 48 and 49 from off-campus courses. However, with respect to student athletes as defined in Article 64 of these Regulations who have been selected as members of a national team as defined in the National Sports Promotion Act, the maximum number of credits that may be acquired from off-campus

courses (limited to regular semester courses) shall not exceed 10 credits per semester.

- (2) Credits acquired from off-campus courses may be acknowledged, provided that the number of credits acknowledged does not exceed one-half of the required minimum for graduation. With respect to transfer students, the number of credits acquired from off-campus courses that may be acknowledged shall not exceed one-half of the credits required by the University (in addition to the credits acquired during their enrollment at their previous school and acknowledged as those acquired from the University).
- Article 55 (Field Practicum and Credit Acknowledgment) (1) Students may participate in field practicum conducted at domestic or foreign institutions (including companies) and acquire credits for participation. (2) Details of matters pertaining to the administration of field practicum shall be separately provided for in Detailed Enforcement Regulations on the Operation of the Field Practicum Semester System. Amended on Sep. 1, 2021
- Article 55–2 (Credit Acknowledgment for Business Start-up Activities) (1) The University may establish and administer a credit acknowledge system for students engaged in business start-up activities to promote and encourage student entrepreneurship.
 - (2) Details of matters pertaining to credit acknowledgement for business start-up activities shall be separately provided for in the *Regulations on Support for Student Business Start-up*. Newly inserted on Mar. 1, 2022
- Article 55–3 (Credit Acknowledgement for Military Training at the Army Cadet Military School) (1) Students in the ROTC may acquire credits from participating in military training conducted at the Army Cadet Military School during summer and winter holidays.
 - (2) Details of matters pertaining to credit acknowledgement for military training at the Army Cadet Military School shall be separately provided for in the *Regulations on the Operation of the Korea University ROTC (Seoul)* and the *Regulations on the Operation of the Korea University ROTC (Sejong)*. Newly inserted on Sep. 1, 2022 and amended on Sep. 1, 2024

Section 5. Graduation

- Article 56 (Basic Requirements for Graduation) (1) In order to graduate from their bachelor's degree program, students must meet all of the requirements set forth in the following subparagraphs:
 - 1. Students must have acquired the number of credits required for graduation;
 - 2. Students must have acquired the minimum required credits for the general studies curriculum determined by each department;
 - 3. Students must have acquired the minimum required credits for their first major (basic major courses) and second major (or intensive major);
 - 4. Students must have acquired an overall GPA of at least 1.75;
 - 5. Students must have met other graduation requirements set forth by their affiliated department.
 - (2) Students on leave of absence are not eligible to gradate even if they have met the requirements for graduation. However, students pursuing a dual major who withdraw from completing the dual major while on leave of absence may graduate with a degree awarded for their first major.
- Article 57 (Credits Required for Graduation) (1) The number of credits required for graduation in subparagraph 1 of Article 56(1) shall be 130 credits.
 - (2) The number of credits required for graduation for students affiliated with the following colleges (divisions/schools) or departments shall be as set forth in the following subparagraphs:
 - 1. College of Education: 140 credits;
 - 2. Department of Architecture of the College of Engineering: 160 credits;
 - 3. Department of Medicine of the College of Medicine: 172 credits;
 - 4. Department of Cyber Defense: 150 credits for students admitted up to the 2024 academic year and 140 credits for students admitted starting from the 2025 academic year; *Amended on Mar. 1, 2025*
 - 5. Department of Pharmacy of the College of Pharmacy: 220 credits for newly admitted students (six-year program) and 154 credits for transfer students (four-year program); *Amended on Mar. 1, 2022; Mar. 1, 2025*
 - 6. Deleted on May 1, 2023
 - 7. Department of Communications Engineering: 140 credits. Newly inserted on Aug. 1, 2023
- Article 58 (Early Graduation: General Provisions) (1) Students intending to graduate early in accordance with the Constitution must submit an application for early graduation within the period specified at the beginning of the semester.

- (2) In order to apply for early gradation from their bachelor's degree program, students must meet all of the requirements set forth in the following subparagraphs: *Amended on Mar. 1, 2024*
- 1. Deleted on Mar. 1, 2024
- 2. Students must have acquired an overall GPA of at least 3.85 for all completed courses (including the grades that have been deleted due to course retakes, etc.) without receiving a grade of F; *Amended on Mar. 1, 2024; Sep. 1, 2024*
- 3. Students must have acquired at least 108 credits (departments requiring acquisition of a minimum 135 credits for graduation: at least 112 credits; departments requiring acquisition of a minimum 140 credits for graduation: at least 117 credits) until either the end of fifth or sixth semester; *Moved from subparagraph 2 and amended on Sep. 1, 2024*
- (3) The requirements for early graduation shall be as set forth in the following subparagraphs:
- 1. Students must have met the requirements set forth in Articles 56 and 57;
- 2. Students must have acquired an overall GPA of at least 4.00 for all completed courses throughout their entire school years (including the grades that have been deleted due to course retakes, etc.) without receiving a grade of F. Amended on Sep. 1, 2024
- (4) The GPA specified in subparagraph 2 of paragraph 2 and subparagraph 2 of paragraph 3 shall be based on the grades granted for all courses completed.
- (5) Students falling within any of the categories set forth in the following subparagraphs shall not be eligible for early graduation:
- 1. Students affiliated with the Department of Architecture of the College of Engineering, College of Medicine, Department of Cyber Defense, and Department of Pharmacy of the College of Pharmacy; *Amended on Mar. 1, 2025*
- 2. Transfer students;
- 3. Students who have received academic warnings.
- Article 59 (Early Graduation: Special Provisions) In addition to early graduation under Article 58, the University may establish and implement other types of early graduation acknowledged by relevant law.
- Article 60 (Early Graduation of Combined Bachelor-Master Degree Program Students) The requirements set forth in Article 58 shall apply to early graduation of combined bachelor-master degree program students.
- Article 61 (Degree Title and Certificate) (1) Each college (division/school) or department shall confer a bachelor's degree on students who have met the requirements for graduation, and the title of the degree conferred shall be as set forth in Annex 1.
 - (2) Certificate of graduation awarded to students who acquire a bachelor's degree shall be as specified in Annex Form 1 (Korean) and Annex Form 2 (English).
- Article 62 (Revocation of a Degree) With respect to those who have acquired a bachelor's degree from the University, the degree shall be revoked in the event it is later found that they have not met the requirements for graduation.
- Article 62–2 (Degree Completion and Deferral of Bachelor's Degree Acquisition) (1) Students who have completed the required registration period specified in Article 37(1) and fulfilled the requirements for degree conferral set forth in subparagraphs 1 to 4 of Article 56(1) but have failed to satisfy the requirement under subparagraph 5 of Article 56(1) shall be regarded as candidates for a bachelor's degree.
 - (2) Students who have completed the required registration period specified in Article 37(1) and fulfilled all of the requirements for degree conferral set forth in Article 56(1) but intending to defer graduation may apply for deferral of bachelor's degree acquisition within the designated period. Details of matters pertaining to this issue shall be separately provided for in the *Detailed Enforcement Regulations on the Deferral of Bachelor's Degree Acquisition. Newly inserted on Sep. 1, 2024*

Section 6. International Students

- Article 63 (International Students) Parts of the administration of academic affairs may be implemented differently for international students upon consideration of particular circumstances pertaining to international students.
 - 1. Exceptions may be granted to international students regarding the requirement to complete required general education courses. *Amended on Sep. 1, 2024*
 - 2. International students who are considered to have insufficient language proficiency to take major courses may be restricted from taking such courses.
 - 3. International students who are considered to have insufficient Korean language proficiency must in

principle complete intensive Korean language courses.

4. Details of matters pertaining to the administration of academic affairs for international students shall be separately provided for in detailed enforcement regulations.

Section 7. Student Athletes

- Article 64 (Students Athletes) (1) Students athletes refer to student sports players registered with the Sports Committee of the University.
 - (2) Parts of the administration of academic affairs may be implemented differently for student athletes upon consideration of particular circumstances pertaining to student athletes. Details of matters pertaining to the administration of academic affairs for student athletes shall be separately provided for in detailed enforcement regulations.

Section 8. Flexible Semester System

- Article 65 (Flexible Semester System) (1) A flexible semester system may be established under which part of the school days designated in accordance with Article 22 of the Constitution may be arranged flexibly in the manner set forth in the following subparagraphs:
 - 1. Intensive lecture courses;
 - 2. Other forms acknowledged by relevant law.
 - (2) Details of matters pertaining to the administration of a flexible semester system for bachelor's degree programs shall be separately provided for in detailed enforcement regulations. Matters pertaining to the administration of a flexible semester system for each graduate school shall be separately provided for by the graduate school.

Section 9. Tutorial System

- Article 66 (Tutorial System) (1) Some of bachelor's degree program courses may be offered in the form of tutorial courses led by teaching fellows (TFs).
 - (2) Details of matters pertaining to the administration of the tutorial system shall be separately provided for in detailed enforcement regulations.

Section 10. Integrated Bachelor-Master Degree Programs Newly inserted on Apr. 15, 2022

- Article 66–2 (Integrated Bachelor-Master Degree Programs) (1) Integrated bachelor-master degree programs wherein bachelor's degree programs and master's degree programs are integrated may be established in accordance with Article 39 of the Constitution.
 - (2) Matters pertaining to the administration of academic affairs of integrated bachelor-master degree programs shall be separately provided for in the *Detailed Enforcement Regulations on the Operation of Integrated Bachelor-Master Degree Programs. Newly inserted on Apr. 15, 2022*

Chapter 4. Evaluation and Awards

Section 1. Exams and Grades

Article 67 (Exam Period) Exam periods shall be as set forth in the following subparagraphs:

- 1. Midterm exam: undertaken in the middle of a semester;
- 2. Final exam: undertaken at the end of a semester;
- 3. Special exam: undertaken occasionally during a semester depending on the course concerned.
- Article 68 (Evaluation) (1) Evaluation shall be undertaken upon consideration of the results of midterm, final and special exams and assignments. However, methods of evaluation for courses involving experiments, practica, and practical works and other special courses may be separately provided for.
 - (2) Grades shall not be granted in the event misconduct occurs or other wrongful means are used with respect to evaluation of attendance, exam results and assignments. *Newly inserted on Jan. 1, 2022*
- Article 69 (Recognition of Excuse to be Absent from an Exam: Reporting) (1) Students unable to attend an exam due to military service, illness, or other unavoidable reasons must report this fact to the dean of their affiliated college (division/school) before the commencement of the exam.
 - (2) Students failing to report such fact in advance due to unavoidable reasons must report the fact with supporting documentation within ten days from the date when the reason for reporting ceases to exist.

- Article 70 (Recognition of Excuse to be Absent from an Exam: Supporting Documentation) (1) The reasons for requesting the recognition of excuse to be Absent from an exam and required documents to be submitted shall be as set forth in the following subparagraphs:
 - 1. Illness: medical certificate issued by the director of a hospital affiliated with the University or the director of another general hospital;
 - 2. Military service or summons for other military reserve training: copy of notice of enlistment (military conscription notice);
 - 3. Death of a family member (limited to spouse, lineal ascendants or descendants, spouse's lineal ascendants or descendants, and siblings): obituary (submit a copy of the family member's death certificate thereafter):
 - 4. Participation in international games or professional training or educational practicum: relevant supporting documentation;
 - 5. Other unavoidable reasons equivalent to those specified in subparagraphs 1 to 4: relevant supporting documentation.
 - (2) In the event of any of the circumstances specified in paragraph 1, the results of midterm or final exam may be acknowledged as the grade for the semester concerned.
 - (3) In the event any document submitted when requesting recognition of excuse to be absent from an exam is false, a grade shall not be granted and an already finalized grade shall be canceled. *Newly inserted on Jan. 1, 2022*

Article 71 (Grading: Principle) (1) Grades for courses shall be classified and indicated as set forth in the following table:

- (2) Grades shall be granted from A+ (highest) to F (lowest) in accordance with the level of academic performance.
- (3) A grade of P (Pass) shall be granted in the event students pass a course that is subject to Pass/Fail evaluation.
- (4) A grade of S (Satisfactory) shall be granted in the event credits are acknowledged without grade point classification.
- (5) A grade of I (Incomplete) shall be granted in the event evaluation within the semester concerned is temporarily deferred. If the grade is not finalized within the specified period, the grade of I shall automatically be converted to the grade of F.
- (6) Grades set forth in the following subparagraphs shall be considered as meriting credit acquisition:
- 1. Grades from A+ to D;
- 2. Grades P and S.
- Article 72 (Grading: Pass/Fail Evaluation) Courses subject to Pass/Fail evaluation shall be as set forth in the following subparagraphs:
 - 1. Courses involving experiments, practica, and practical works;
 - 2. Other courses recognized as suitable for Pass/Fail evaluation.
- Article 73 (Grade Calculation and Recording) (1) Grades shall be recorded in accordance with grades set forth in Article 71, and the GPA shall be calculated by multiplying the grade points earned in a course by the number of credits acquired for that course, taking the sum of such products for each course taken, and finally dividing that sum by the total number of credits acquired; the GPA shall be rounded to the nearest thousandth decimal places.
 - (2) A grade of F shall be indicated with "NA" (Not Applicable) together with the course name on the academic transcript.

- (2) The highest possible grade for retaken courses shall be A (grade points: 4.00). The highest possible grade for courses that have been taken for the third time shall be B+ (grade points: 3.50).
- (3) The grade of a retaken course shall be compared with the grade originally acquired so that the higher of the two shall be reflected in the GPA on the academic transcript; however, retaken courses shall also be indicated on the academic transcript.
- (4) The course to which the lower of the two grades has been granted that is not reflected in the GPA on the academic transcript shall be indicated with "R" (Retake).
- (5) Courses established at the Sejong Campus after the spring semester of 2016 may be retaken only once. However, retakes of courses with a grade of F shall not be subject to the restrictions on the number of course retakes.
- Article 75 (Grade Correction and Cancellation) (1) Students objecting to their grades may file an objection with the professor in charge during the grade announcement and correction period.
 - (2) Grades may be corrected only in the event where the student is not at fault in the occurrence of an error that rendered grade correction necessary, such as an error in evaluation or grade input by the professor in charge.
 - (3) Credits that have been acquired shall be cancelled in the event it is discovered that they have been acquired through misconduct or other wrongful means.
- Article 76 (Evaluation and Grading) (1) Grading shall be undertaken on an absolute basis. However, relative grading shall be undertaken for courses falling within any of the categories set forth in the following subparagraphs:
 - 1. Courses designated by the departments establishing them due to the particular nature of such courses (relative grading must be undertaken on a course-by-course basis);
 - 2. Deleted on Mar. 1, 2024
 - (2) Deleted on Mar. 1, 2024
 - (3) The grading percentile (cumulative) for courses subject to relative grading shall be as set forth in the following subparagraphs:
 - 1. General:

2. Courses involving experiments and practica, teacher training courses, courses taught in foreign languages, and general foreign language courses:

- (4) Details of matters pertaining to the evaluation and grading system of the Sejong Campus shall be provided for in the *Guidelines on Evaluation and Grading for the Sejong Campus Bachelor's Degree Programs. Amended on Sep. 1, 2024*
- Article 76–2 (Registration and Attendance of Courses by Children of Faculty Members) (1) In the event a child of a faculty member in charge of a course registers for and attends the course, the faculty member must report this fact to the department chair immediately after such registration in the course is confirmed. The department chair must submit this fact to the Educational Affairs Team of the Office of Academic Affairs.
 - (2) Faculty members who report their children's registration and attendance of the course they are in charge of in accordance with paragraph 1 must submit to their department chair the grounds for grade calculation upon granting final grades. The department chair must review the grounds and submit them to the Educational Affairs Team of the Office of Academic Affairs.
 - (3) Notwithstanding Article 30(1) of the *Detailed Enforcement Regulations on the Organization and Operation of Curricula*, faculty members specified in paragraph 2 must retain records related to their children's attendance and grades for a period of ten years.
 - (4) With respect to faculty members who violate the obligations set forth in paragraphs 1 to 3, necessary measures may be undertaken in accordance with the *Regulations on Personnel Affairs of Faculty Members*.

Newly inserted on Sep. 1, 2021

- Article 77 (Academic Warning) (1) Academic warning shall be issued to students with a GPA of less than 1.75 for a semester, and the fact that an academic warning was issued shall be recorded in the Student Register.
 - (2) With respect to students who have received an academic warning, the fact that an academic warning was issued shall be reported to the students themselves and their guardian and academic advisor (department head).
 - (3) Students who receive academic warnings three consecutive times shall be withdrawn.
 - (4) Academic warning shall be issued to students who register for less than 12 credits per semester; such academic warning shall not be counted toward the number of issuance of consecutive academic warnings in paragraph 3.

Section 2. Honor Students

- Article 78 (Semester Honor Students) To be eligible to be selected as semester honor students, students must meet the requirements set forth in the following subparagraphs:
 - 1. Common requirements: students must have acquired at least 17 credits (18 credits for the colleges (divisions/schools) and departments specified in Article 57(2); 12 credits for the last school year of the required registration period) without receiving a grade of F in any of the courses completed in the given semester; *Amended on Sep. 1, 2024*
 - 2. Semester honor students: students must have acquired a GPA of at least 3.75 (based on the grades acquired in all courses completed for the semester);
 - 3. Semester high honor students: students must have acquired a GPA of at least 4.0 (based on the grades acquired in all courses completed for the semester).
- Article 79 (Honor Students for Graduation) To be eligible to be selected as honor students for graduation, students must meet the requirements set forth in the following subparagraphs:
 - 1. Common requirements: students must have been admitted as new students, met all graduation requirements, and not received a grade of F in all of the courses completed throughout their entire school years; *Amended on Sep. 1, 2024*
 - 2. Honor students for graduation: students must have acquired an overall GPA of at least 3.75 (based on the grades acquired in all courses completed);
 - 3. High honor students for graduation: students must have acquired an overall GPA of at least 4.00 (based on the grades acquired in all courses completed);
 - 4. Highest honor students for graduation: students must have acquired an exceptional overall GPA and be recommended by their affiliated college (division/school).

Article 80 Deleted

- Article 81 (Academic Excellence Awards) To be eligible for an academic excellence award, students must meet the requirements set forth in the following subparagraphs:
 - 1. Common requirements: students must have acquired at least 17 credits (18 credits for the colleges (divisions/schools) and departments specified in Article 57(2)), provided that the results of grade corrections after the date of finalization of grades shall not be considered; *Amended on Sep. 1, 2024*
 - 2. Dean's Award: students must have acquired a GPA of at least 4.5 for the semester concerned (grades corrected after finalization shall not be reflected in the GPA);
 - 3. President's Award: students must have acquired a GPA of at least 4.5 for two consecutive semesters (grades corrected after finalization shall not be reflected in the GPA) and not been on a leave of absence in the immediately preceding semester.
- Article 82 (Recording in the Student Register and Recognition) (1) Semester honor students, honor students for graduation, and academic excellence award recipients shall have their recognition recorded in the Student Register and their certificate of award; honor students for graduation also shall have their recognition indicated on the certificate of graduation. *Amended on Sep. 1, 2024*
 - (2) Academic excellence award recipients and highest honor students for graduation shall be granted awards. *Amended on Sep. 1, 2024*

Chapter 5. Curricula

Section 1. General Provisions

- Article 83 (Curricula) (1) Each college (division/school) and department shall establish and administer a curriculum in accordance with Article 34 of the Constitution of Korea University. Amended on Sep. 1, 2024
 - (2) Details of matters pertaining to curriculum organization and operation shall be separately provided for in detailed enforcement regulations.
- Article 84 (Course Classification) (1) Courses shall be classified as set forth in the following subparagraphs:
 - 1. General education courses;
 - 2. Major courses.
 - (2) In addition to the classification in paragraph 1, special classification, such as academic foundation courses and teacher training courses, may be established.
- Article 85 (Designation of Similar Courses) (1) Courses abolished or modified due to reorganization of the curriculum may be replaced by currently established course designated as similar courses.
 - (2) Similar courses shall not be designated for courses for which at least eight years have elapsed since their abolition, and such courses may be deleted from the list of courses offered by the University.
- Article 86 (Committee) A committee shall be established to deliberate on major policies necessary for curriculum organization and management, and matters pertaining to its composition and operation shall be separately provided for in regulations.
- Article 87 (Curricula for Teacher Training and Continuing Education Programs) Curricula for teacher training and continuing education programs shall be separately provided for in detailed enforcement regulations.
- Article 87–2 (Academic Foundation Courses) (1) Departments may establish academic foundation courses for the basic education of their affiliated students.
 - (2) Students shall complete academic foundation courses in accordance with the curriculum of each department.
- Article 87–3 (Non-curricular Programs) Non-curricular programs may be administered in addition to the courses specified in Article 84, and details of matters pertaining to them shall be separately provided for in for in detailed enforcement regulations.

Section 2. General Education Courses

- Article 88 (Classification of General Education Courses) General education courses shall be classified as set forth in the following subparagraphs:
 - 1. Required general education courses;
 - 2. Core general education courses;
 - 3. Elective general education courses.
- Article 89 (Required General Education Courses) (1) Required general education courses shall consist of courses set forth in the following subparagraphs that students must complete:
 - 1. Liberty Justice Truth: composed of Liberty Justice Truth I and Liberty Justice Truth II that are offered consecutively in the spring and fall semesters; students must take Liberty Justice Truth I prior to taking Liberty Justice Truth II;
 - 2. College Writing: College Writing is offered in the spring and fall semesters by each department;
 - 3. Academic English: composed of Academic English I and Academic English II that are offered consecutively in the spring and fall semesters; students must take Academic English I prior to taking Academic English II;
 - 4. Freshman Seminar: composed of Freshman Seminar I and Freshman Seminar II that are offered consecutively in the spring and fall semesters; students may take these seminar courses in any order;
 - 5. Computational Thinking: students must take this course in the fall semester of their first year;
 - (2) Students must take College Writing and Academic English for the first time in a regular semester, not in a summer or winter semester.
 - (3) The structure and details of required general education courses of the Sejong Campus shall be separately provided.
- Article 90 (Core General Education Courses) (1) Core general education courses shall be categorized into seven specific areas, and students must select and complete at least one course from each of the two areas designated by each department.
 - (2) Students affiliated with the Seoul Campus must complete one course from a humanities-related area

(World Cultures, History, Literature and Art, and Ethics and Philosophy).

Article 91 Deleted

- Article 92 (Elective General Education Courses) (1) Courses related to general studies, arts and physical education may be offered as elective general education courses.
 - (2) Students shall complete elective general education courses in accordance with the curriculum of each department.

Section 3. Majors

- Article 93 (Basic Major Courses Curriculum and Intensive Major Courses Curriculum) Major courses curriculum for each department shall consist of the basic major courses curriculum and the intensive major courses curriculum.
- Article 94 (Credits for the Basic Major Courses Curriculum) The number of credits assigned for the basic major courses curriculum shall be a minimum 36 credits and maximum 42 credits. The number of credits assigned for the basic major courses curriculum of colleges (divisions/schools) and departments specified in Article 57(2) shall be separately provided for in their bylaws.
- Article 95 (Course Classification and Establishment) (1) Major courses shall be classified as set forth in the following subparagraphs:
 - 1. Major required courses;
 - 2. Major elective courses.
 - (2) Major elective courses may be offered every other year.

Section 4. General Elective Courses

- Article 96 (Management of Extra Credits) Credits acquired in excess of required credits designated for general education and major courses shall be managed as credits acquired from general elective courses.
- Article 97 (Conversion of Course Classification) Courses managed as general elective courses may be converted into major courses for a second major, minor, or dual major.

Section 5. Accredited Curricula

- Article 98 (Eligibility and Application) Students affiliated with a department administering an accredited curriculum must in principle complete the accredited curriculum; however, such students may elect to complete the general curriculum set forth in University regulations.
- Article 99 (Course Completion) Students following an accredited curriculum must complete courses required for accreditation designated by the department administering the accredited curriculum.
- Article 100 (Withdrawal from Accredited Program) Students intending to withdraw from following an accredited curriculum must submit a voluntary withdrawal form to each department within the period specified in the bylaws of each college (division/school).
- Article 101 (Certificates) Certificates issued for students who have completed an accredited curriculum shall indicate the name of the major of the accredited curriculum.

Section 6. Certification Programs Newly inserted on Sep. 1, 2022

- Article 101–2 (Certification Programs) Types of certification programs specified in Article 38–2 of the *Constitution of Korea University* shall be as set forth in the following subparagraphs:
 - 1. Microdegrees;
 - 2. Concentration tracks within majors.

Newly inserted on Sep. 1, 2022

Article 101–3 (Microdegrees) Colleges, departments, and University institutions may design and administer microdegrees, and matters pertaining to the operation of microdegrees shall be separately provided for in the *Detailed Enforcement Regulations on the Operation of Microdegrees*. *Newly inserted on Sep. 1*, 2022

Article 101–4 (Concentration Tracks) Colleges and departments may design and administer concentration tracks within a major, and matters pertaining to the operation of concentration tracks shall be separately provided for in their bylaws. *Newly inserted on Sep. 1, 2022*

Chapter 6. Intensive Majors and Second Majors

Section 1. Intensive Majors

- Article 102 (Entrance Procedures and Course Completion) (1) Students may pursue an intensive major without having to undertake a separate application procedure.
 - (2) Intensive major students must complete major courses specified in the curriculum of their affiliated department.
- Article 103 (Certificates) Certificates issued for students who have completed an intensive major shall indicate their completion of the intensive major.

Section 2. Second Majors

Subsection 1. Double Majors

- Article 104 (Eligibility and Application) (1) Students intending to pursue a double major may apply for a double major within the specified period upon commencement of the third semester of their study.
 - (2) Transfer students may apply for a double major after completing one semester at the University.
 - (3) Students on leave of absence shall not be eligible to apply for a double major.
- Article 105 (Scope of Application and Student Quota) (1) Students may pursue a double major in any of the departments of the University. However, students shall not pursue a double major in the colleges (divisions/schools) and departments set forth in the following subparagraphs:
 - 1. College of Medicine;
 - 2. College of Nursing;
 - 3. Department of Cyber Defense;
 - 4. Department of Pharmacy of the College of Pharmacy; Amended on Mar. 1, 2025
 - 5. Department of Semiconductor Engineering;
 - 6. Department of Communications Engineering; Newly inserted on Aug. 1, 2023
 - 7. School of Smart Mobility. Newly inserted on Aug. 1, 2023
 - (2) Only students affiliated with the College of Education may pursue a double major in a department of the College of Education.
 - (3) In the event identical or similar departments are established at both the Seoul Campus and Sejong Campus, students must pursue a double major at the campus where they are pursuing their first major. Departments of the Seoul (Sejong) Campus where Sejong (Seoul) Campus students may pursue a double major shall be as set forth in Annex 2.
 - (4) Student quotas of double majors shall be as set forth in the following subparagraphs:
 - 1. The number of students who may pursue a double major in a department shall be determined upon consideration of educational conditions and seating capacity of the department and shall be equal to the number obtained by subtracting the number of intensive major students from 150% of the admission quota of the department. However, the quota for double major students may be adjusted upon request by the department. *Amended on Sep. 1, 2024*
 - 2. The quota for double major students for a department in the College of Education shall be within 100% of the admission quota of the department. *Amended on Sep. 1, 2024*
 - 3. The number of Seoul (Sejong) Campus students who may pursue a double major at the Sejong (Seoul) Campus shall be within 30% of the quota set forth in subparagraph 1.
- Article 106 (Selection) (1) Students applying for a double major must undergo a prescribed selection process and obtain permission from the President. Applicants may apply for first and second preferences.
 - (2) The selection process in paragraph 1 shall involve the selection of first preference applicants in the order of academic performance, which shall be followed by the selection of second preference applicants in the order of academic performance.
 - (3) Each department may establish and implement bylaws on the selection criteria for double major students.

- Article 107 (Credit Acquisition and Acknowledgement) (1) Double major students must acquire at least the minimum required credits for the major courses specified in the curriculum of the department offering the double major they are pursuing.
 - (2) Credits acquired by double major students from courses offered under their double major programs before applying for the double major shall be acknowledged as credits acquired from double major courses.
- Article 108 (Withdrawal from Completion) (1) Double major students intending to withdraw from completing their double major and apply for another second major (not an intensive major) must apply for withdrawal before the expiration of the application period for a second major in accordance with prescribed procedures.
 - (2) Double major students intending to withdraw from pursuing their double major and apply for an intensive major must apply for withdrawal no later than one month before the end of the semester concerned (end of January or July).
 - (3) Students may apply for a change of their second major in paragraph 1 only once. However, applications made in the circumstances set forth in the following subparagraphs shall not be counted toward the number of applications made to change a second major:
 - 1. In the event the student changed their affiliation to another department at another campus at which he/she is selected to pursue a double major;
 - 2. In the event the department the student transferred from is processed as the department where the student pursued a double major in accordance with Article 8(2) of the *Detailed Enforcement Regulations on Department Transfers Following Intra-Campus Affiliation Changes*.

 Amended on Mar. 1, 2022
- Article 109 (Assessment and Timing of Graduation) (1) Colleges (divisions/schools) offering a double major shall verify whether students pursuing a second major have met graduation requirements and notify the result of such verification to the colleges (divisions/schools) where the students are pursuing their first major.
 - (2) Students pursuing a double major shall not be eligible to graduate until they meet all graduation requirements for their first major and double major.
- Article 110 (Degree Conferral) Students pursuing a double major who have met all graduation requirements for their first major and double major shall be awarded with the degree of each major simultaneously.
- Article 111 (Certificates) Certificates issued for students who have completed a second major shall indicate information as set forth in the following subparagraphs:
 - 1. Certificate of Enrollment: both first major and double major shall be indicated;
 - 2. Academic Transcript: both first major and double major shall be indicated.
 - 3. Certificate of Graduation: both first major and double major shall be indicated.

Subsection 2. Interdisciplinary Majors

- Article 112 (Eligibility and Application, Etc.) (1) Article 104 shall apply mutatis mutandis to both eligibility and application concerning interdisciplinary majors.
 - (2) Types of interdisciplinary majors, colleges (graduate schools) and institutions in charge of establishing and operating interdisciplinary majors, participating departments, and degree titles shall be as set forth in Annex 3

Amended on Sep. 1, 2022

- Article 113 (Number of Selectees and Selection) (1) Matters pertaining to student quotas, number of selectees, and selection criteria for interdisciplinary majors shall be determined by each interdisciplinary major council.
 - (2) Students applying for an interdisciplinary major must undergo a prescribed selection process and obtain permission from the President.
- Article 114 (Credit Acquisition and Acknowledgement) (1) Interdisciplinary major students must acquire at least the minimum required credits for the major courses specified in the curriculum of the department offering the interdisciplinary major they are pursuing.
 - (2) Credits acquired by interdisciplinary major students from courses offered under their interdisciplinary major programs before applying for the interdisciplinary major shall be acknowledged as credits acquired from interdisciplinary major courses.

- (3) Courses completed while pursuing an interdisciplinary major shall not be acknowledged as courses completed for the first major, minor or dual major. However, credits acquired in excess of 30 credits while pursuing an interdisciplinary major may be acknowledged as courses completed for the first major.
- Article 115 (Withdrawal from Completion) Article 108 shall apply mutatis mutandis to withdrawals from completion of an interdisciplinary major.
- Article 116 (Assessment and Timing of Graduation) (1) Graduation assessment for interdisciplinary majors shall be conducted by each interdisciplinary major council.
 - (2) Colleges (graduate schools) and institutions in charge of an interdisciplinary major shall verify whether students pursuing the interdisciplinary major have met graduation requirements and notify the result of such verification to the colleges (divisions/schools) where the students are pursuing their first major. *Amended on Sep. 1*, 2022
 - (3) Students pursuing an interdisciplinary major shall not be eligible to graduate until they meet all graduation requirements for their first major and interdisciplinary major
- Article 117 (Degree Conferral) Students pursuing an interdisciplinary major who have met all graduation requirements for their first major and interdisciplinary major shall be awarded with the degree of each major simultaneously.
- Article 118 (Certificates) Article 111 shall apply mutatis mutandis to certificates concerning interdisciplinary majors.
- Article 119 (Guidelines) Details of matters pertaining to the operation of interdisciplinary majors shall be separately provided for in guidelines.

Subsection 3. Student-Designed Majors

- Article 120 (Eligibility and Application) Article 104 shall apply mutatis mutandis to both eligibility and application concerning student-designed majors.
- Article 121 (Number of Selectees and Selection) (1) Matters pertaining to student quotas, number of selectees, and selection criteria for student-designed majors shall be determined upon deliberation by the Curriculum Steering Committee. *Amended on Sep. 1, 2024*
 - (2) The procedure and method for selecting students applying for student-designed majors shall be as set forth in the following subparagraphs:
 - 1. Recommendation of applicants by the academic advisor of the student-designed major;
 - 2. Deliberation by the Student-Designed Major Committee; Newly inserted on Sep. 1, 2024
 - 3. Deliberation by the Curriculum Steering Committee; Moved from subparagraph 2 on Sep. 1, 2024
 - 4. Permission by the President. Moved from subparagraph 3 on Sep. 1, 2024
- Article 122 (Credit Acquisition and Acknowledgement) (1) Student-designed major students must complete the courses specified in the curriculum approved by the President.
 - (2) Credits acquired by student-designed major students from courses offered under their student-designed major programs before applying for the student-designed major shall be acknowledged as credits acquired from student-designed major courses.
 - (3) Courses completed while pursuing a student-designed major shall not be acknowledged as courses completed for the first major, minor or dual major.
- Article 123 (Withdrawal from Completion) (1) Student-designed major students withdrawing from pursuing their student-designed major shall no longer be able to pursue a student-designed major.
 - (2) Article 108 shall apply mutatis mutandis to students withdrawing from pursuing a student-designed major and intending to pursue another.
- Article 124 (Assessment and Timing of Graduation) (1) Graduation assessment for student-designed majors shall be conducted by the departments with which the academic advisors of the student-designed majors are affiliated.
 - (2) Students pursuing a student-designed major shall not be eligible to graduate until they meet all graduation requirements for their first major and student-designed major.
- Article 125 (Degree Conferral) Students pursuing a student-designed major who have met all graduation

- requirements for their first major and student-designed major shall be awarded with the degree of each major simultaneously.
- Article 126 (Certificates) Article 111 shall apply mutatis mutandis to certificates concerning student-designed majors.
- Article 127 (Guidelines) Details of matters pertaining to the operation of student-designed majors shall be separately provided for in guidelines.

Chapter 7. Minors and Dual Majors

Section 1. Minors

- Article 128 (Eligibility and Application) Deleted
- Article 129 (Course Completion for Minors) Students pursuing a minor must complete courses designated by the department offering the minor they are pursuing.
- Article 130 (Scope of Application) Deleted
- Article 131 (Pursuing a Minor at the Other Campus) Students pursuing a minor at the campus other than their affiliated campus may take courses at the other campus provided that the number of credits acquired from that other campus does not exceed the required minimum for completion of their minor.
- Article 132 (Acknowledgement of Courses Completed by Transfer Students) Courses completed by transfer students at the University may only be acknowledged as courses completed for their minor.

Section 2. Dual Major

- Article 133 (Eligibility and Timing of Entrance) (1) To be eligible to apply for a dual major, students must have acquired a minimum of 102 credits (34 credits for second bachelor's degree transfer students) in accordance with a prescribed curriculum and acquired a GPA of at least 2.50.
 - (2) Students pursuing a dual major may enter dual major program only after meeting the requirements set forth in Articles 56 and 57.
- Article 134 (Scope of Application and Student Quota) (1) Articles 105(1) and 105(2) shall apply mutatis mutandis to the scope of application for dual majors. *Amended on Mar. 1, 2022*
 - (2) Students affiliated with a department established at the Seoul (Sejong) Campus shall not pursue a dual major in a department established at the Sejong (Seoul) Campus that is identical or similar to their affiliated department.
 - (3) The number of students who may pursue a dual major in a department shall be limited upon consideration of the educational conditions of the department.
- Article 135 (Selection) (1) Students intending to pursue a dual major must submit an application within the specified period and obtain permission from the President.
 - (2) Document screening and oral interview shall be conducted for students applying for a dual major. Performance test may be additionally conducted for students applying for a dual major in an arts or physical education department.
 - (3) Dual major students shall not apply for a dual major in another department.
- Article 136 (Credit Acknowledgement) (1) Students pursuing a dual major must submit the request for course acknowledgment and academic transcript to the administration office of the college (division/school) offering their dual major within the designated period before the commencement of the dual major program. *Amended on Mar. 1, 2022; Sep. 1, 2024*
 - (2) Credits acquired by dual major students from courses offered under their dual major programs before applying for the dual major shall be acknowledged as credits acquired from dual major courses upon approval by the department chair and the dean of the college (division/school), provided that the number of credits acknowledged shall not exceed 21 credits.
 - (3) In the event students pursue a dual major in the department where they have completed a minor, the minor shall no longer be acknowledged as having been completed.

- Article 137 (Credit Acquisition) (1) Dual major students must complete the courses specified in the curriculum of the department offering the dual major they are pursuing.
 - (2) Each department may designate additional courses that dual major students must complete in addition to courses specified in paragraph 1.
- Article 138 (Withdrawal from Completion) Types of withdrawals concerning dual majors shall be as set forth in the following subparagraphs:
 - 1. Withdrawal prior to entry: withdrawal from pursuing a dual major after passing the selection process and before commencing the dual major program;
 - 2. Mid-course withdrawal: withdrawal from pursuing a dual major after passing the selection process and commencing the dual major program.
- Article 139 (Withdrawal prior to Entry) (1) Students having been admitted to a dual major and subsequently intending to withdraw from pursuing the dual major before commencing the dual major program must submit a voluntary withdrawal form to the administration office of their affiliated college (division/school) no later than one month before the end of the final semester of their first major (end of January or July). *Amended on Mar. 1, 2022; Sep. 1, 2024*
 - (2) Students who have submitted the voluntary withdrawal as specified in paragraph 1 shall be awarded with the degree of their first major on the degree conferral date scheduled for the semester concerned.
 - (3) Students who have withdrawn from pursuing a dual major before commencing the dual major program shall not be eligible for readmission to the department at which they had initially intended to pursue the dual major.
- Article 140 (Mid-course Withdrawal) (1) Dual major students intending to withdraw from pursuing their dual major must apply for withdrawal no later than one month before the end of the semester concerned (end of January or July) in accordance with prescribed procedures.
 - (2) Students who have applied for withdrawal as specified in paragraph 1 shall be awarded with the degree of their first major on the degree conferral date scheduled for the semester concerned.
 - (3) Students who have neither applied for withdrawal nor registered before the prescribed deadline shall be awarded with the degree of their first major on the degree conferral date scheduled for the semester concerned.
 - (4) Students who have withdrawn from pursuing a dual major in the course of the dual major program shall not be eligible for readmission to the department at which they had initially intended to pursue the dual major.
- Article 141 (Degree Conferral) (1) With respect to dual major students, conferral of the degree of their first major shall be deferred until they complete their dual major.
 - (2) Students pursuing a dual major who have met all graduation requirements for their dual major shall be awarded with the degree of their first major and dual major simultaneously.
- Article 142 (Certificates) (1) Certificates issued for students who have completed a dual major shall indicate information as set forth in the following subparagraphs:
 - 1. Certificate of Enrollment: the certificate shall include the text "The above individual has completed his/her first major and is currently pursuing a dual major";
 - 2. Academic transcript: separate academic transcripts shall be issued for the first major and dual major; during enrollment, the fact the student is currently pursuing a dual major shall be indicated;
 - 3. Certificate of Graduation and Certificate of Completion: separate Certificates of Graduation shall be issued for the first major and dual major (the Certificate of Completion issued for the first major while the student is pursuing a dual major shall include the text "The above individual has completed his/her first major and is currently pursuing a dual major").
 - (2) For students who have withdrawn from pursuing a dual major in the course of the dual major program, certificates shall be issued as set forth in the following subparagraphs:
 - 1. Academic transcript: the academic transcript for the first major shall be issued in the manner identical to that issued after graduation, and the academic transcript for the dual major shall include grades acquired up to the last semester completed while pursuing the dual major;
 - 2. Certificate of Graduation: shall be issued only for the first major.

Article 1 (Date of Enforcement) These Regulations shall enter into force on March 1, 2014.

Article 2 (University Regulations to be Repealed) The University regulations set forth in the following subparagraphs shall be repealed upon enforcement of these Regulations:

- 1. Detailed Enforcement Regulations of the Constitution (I);
- 2. Bylaws on Academic Affairs.

Article 3 (Interim Measures concerning Time Limit for Degree Completion) With respect to the application of a time limit for degree completion set forth in Article 38, the time limit for degree completion for students admitted prior to 2013 shall be as set forth in the following subparagraphs:

- 1. Students in their final school year as of March 1, 2014: the period corresponding to the required registration period set forth in Article 37(1), calculated as commencing from March 1, 2014;
- 2. Students having one school year remaining prior to their final school year as of March 1, 2014: the period corresponding to the required registration period set forth in Article 37(1) extended by one year, calculated as commencing from March 1, 2014;
- 3. Students having two school years remaining prior to their final school year as of March 1, 2014: the period corresponding to the required registration period set forth in Article 37(1) extended by two years, calculated as commencing from March 1, 2014;
- 4. Students having three school years remaining prior to their final school year as of March 1, 2014: the period corresponding to the required registration period set forth in Article 37(1) extended by three years, calculated as commencing from March 1, 2014;
- 5. Students having at least four school years remaining prior to their final school year as of March 1, 2014: the period corresponding to the required registration period set forth in Article 37(1) extended by four years, calculated as commencing from March 1, 2014.

Article 4 (Interim Measures concerning Withdrawal of Acquired Credits) (1) Article 51 shall apply commencing with courses completed after the spring semester of 2014.

- (2) A maximum of six credits acquired before the spring semester of 2014 may be withdrawn. Qualifications of students eligible to withdraw acquired credits and procedures for withdrawal shall be as set forth in the following subparagraphs:
- 1. Students must have registered for at least seven semesters and acquired a minimum of 102 credits (106 credits);
- 2. Students must submit an Application for Credit Withdrawal form within the specified period.
- (3) The Application for Credit Withdrawal form in subparagraph 1 of paragraph 2 may be submitted only once, and such application shall not be withdrawn or modified.
- (4) Courses for which credits have been withdrawn in accordance with paragraph 2 shall not be registered for again.
- Article 5 (Special Provisions on Credits Required for Graduation for the College of Medicine) (1) Notwithstanding subparagraph 3 of Article 57(2), the number of credits required for graduation shall be reduced in the cases set forth in the following subparagraphs:
- 1. Students graduated in 2013: 166 credits;
- 2. Students graduating in 2014: 170 credits.
- (2) Paragraph 1 shall apply irrespective of the date of enforcement set forth in Article 1 of the Supplementary Provisions.

Article 6 (Interim Measures concerning the Grade of "NA" on Academic Transcripts) Article 73(2) shall apply commencing with courses completed after the spring semester of 2014.

Article 7 (Interim Measures concerning Amendment to the Provisions on Course Retakes) Paragraphs 2 to 4 of Article 74 on course retakes shall apply commencing with courses completed after the spring semester of 2014.

Article 8 (Interim Measures concerning Minors and Dual Major in the Departments of the College of Education) (1) Students admitted after 2008 (including transfer students) shall not pursue a minor in any of the departments of the College of Education.

(2) Students pursuing a dual major in a department of the College of Education after 2006 may be selected by the department provided that a quota is reserved for students pursuing a double major or minor in that department. Students pursuing a dual major in a department of the College of Education after 2008 may be selected by the department provided that a quota is reserved for students pursuing a double major in that department.

Article 9 (Interim Measures concerning Combined Majors) Combined majors operated before the date of

enforcement of these Regulations shall operate under the changed name "interdisciplinary majors" commencing from March 1, 2014.

Article 10 (Interim Measures concerning Second Majors) (1) Students admitted after 2004 who have failed to pursue a double major, student-designed major, or interdisciplinary major must complete both a basic major course program established by their affiliated department and an intensive course program related to their first major.

- (2) In the event that there is no remaining quota in the department concerned for the year of their admission, students admitted after 2004 shall not pursue a double major in that department since they are permitted to pursue a double major within the quota set forth in Article 105(4).
- (3) The quota for students admitted in 2006 and 2007 pursuing a double major in any of the departments of the College of Education shall be within 90% of the admission quota for each department.
- (4) With respect to students admitted in and before 2003, students pursuing a double major (Article 106(2)) shall be selected based on their academic performance.
